New Clause added

1. In the tender **page No.6** in **Scope of Work** additional equipment added for repairing, servicing, upgradation and AMC as follows:

Section B

11.8 Repairing, servicing and Upgradation of Air Compressors as mentioned in the table below: -

- 11.8.1. The deputed service engineer/technician may inspect the compressors during the specified period (on working days), between specified time with prior intimation to our designated contact person.
- 11.8.2. The report should include the present status of the items to be serviced, repaired/up-graded with necessary spare parts (required if any).

- 11.8.3. The items which are non- functional and beyond economic repair should be certified with the necessary justification to enable the IMU MPC to replace the same with a new one.
 - 11.8.4. In case of the replacement of old damaged/ non-working instruments/apparatus/ machines are required, the agency may suggest upgraded/advanced certified new machines available with the authorized suppliers/original manufacturers.
 - 11.8.5. The Tenders must be submitted along with the inspection report, failing to which it will be treated as the Tender is cancelled.
 - 11.8.6. The duration of service period is 30 working days from the issue of work order.
 - 11.8.7. The warranty of the working of laboratory/ workshop equipment/ machines should be at least of three year after the servicing of the same plus two year AMC.
 - 11.8.8. The completion certificate with the confirmation of respective laboratory In-charges has to be submitted along with the bill.

2. In the tender page No. 5, Para No.9 (Payment Term) additional clause added as follows:

9.3 Repair and Servicing of equipment:

The payment w.r.t. repair/servicing/up-gradation will be made only after the successful completion of the respective activity and trials.
